## **Text of the report:**

SECO/WARWICK S.A. announces that at the Supervisory Board's meeting held on December 8th 2016 Mr Sławomir Woźniak and Mr Bartosz Klinowski were appointed Members of the Management Board of SECO/WARWICK S.A. with effect from January 2nd 2017.

Mr Sławomir Woźniak is a graduate of the Zielona Góra University of Technology. His professional career began at SECO/WARWICK (1994), where he worked first as a Serviceman and then Deputy Manager of the CAB Plant. In 2005, Mr Woźniak was appointed Manager of the CAB Plant. In 2010, he was seconded to SECO/WARWICK Retech, SECO/WARWICK S.A.'s Chinese subsidiary, to serve as Deputy Managing Director. In 2011–2012, he was Managing Director at SECO/WARWICK Retech. In 2013 and 2014, Mr Woźniak served as Managing Director at SECO/WARWICK Allied of India and Chief Operating Officer of the SECO/WARWICK Group. In 2014, he was reappointed Managing Director of SECO/WARWICK Retech and since 2016 he has also held the position of Managing Director at SECO/WARWICK Allied.

Mr Bartosz Klinowski is a graduate of the Wrocław University of Technology. In 2008, he completed post-graduate studies in database systems at the Poznań University of Technology. In 2011, Mr Klinowski received an Executive MBA diploma from the Leon Koźmiński University and a Program Management diploma from the Harvard Business ICAN Institute. His professional career began at SECO/WARWICK S.A. (2003), where he worked first as an Engineer to later become Deputy Director of the Electric Plant. In 2011–2012, Mr Klinowski served as Vice-President of the Management Board of SECO/WARWICK Thermal. Since 2013, he has been Member of the Supervisory Board of the Russian subsidiary SECO/WARWICK Rus and President of the Management Board of SECO/WARWICK Europe Sp. z o.o.

The newly appointed Management Board Members are not engaged in any activities competitive to SECO/WARWICK S.A.'s business, are not partners in any partnership under civil law or another type of partnership or members of a governing body of a company or any other legal entity which would conduct activities competitive to the business of SECO/WARWICK S.A.

The appointed Management Board Members are not entered in the Register of Insolvent Debtors maintained pursuant to the Polish National Court Register Act.
